Learning Ready Kids have quality early learning experiences that prepare them for school and life. Kids that are Learning Ready: are developmentally ready to enter school, experience quality early care and education and maintain early gains to succeed academically. In FY21, ReadyKids Learning Ready Programs (Growing Minds, ReadySteps, Family Coordination and STAR Kids) impacted 5,760 kids, families and early childhood educators and 95.8% had quality early learning experiences that prepared them for school and life.

Relationship Ready Kids experience positive, nurturing and healthy family relationships. Kids that are Relationship Ready: experience positive parent/child/family interactions, are free from abuse and neglect, and are more socially-emotionally healthy and related well to others. In FY21, ReadyKids Relationship Ready Programs (Healthy Families, REAL Dads, Teen Counseling and Inside Out Counseling) impacted 1,244 kids, families and early childhood educators and 91.1% experienced nurturing, healthy and developmentally appropriate family relationships.
